## WHAT IS GREEN BANKING MENA?

“Green Banking MENA – Capacity Building on Green Energy and Climate Finance” is a scholarship programme of the Renewables Academy (RENAC) for professionals from Egypt, Jordan, Morocco and Tunisia.

Green Banking MENA is part of the Policy dialogue and knowledge management on low emission strategies in the MENA region (DIAPOL-CE) project, which is funded by the German International Climate Initiative (IKI) with support of the German Federal Ministry for the Environment, Nature Conservation and Nuclear Safety (BMU) and implemented by GIZ.

## OBJECTIVES

Green Banking MENA aims at a sustainable improvement of personal and institutional capacities in the implementing countries in view of financing options for Renewable Energy (RE) and Energy Efficiency (EE).
